Offense: Suspicious Person

Officers were dispatched to a suspicious persons call. The caller stated that there were two individuals looking into vehicles using flashlights. Upon arrival, an officer noticed SAPD working a crash at the location where the suspicious activity was originally reported. SAPD officers were using flashlights to look into the vehicles that were involved in the crash.

An officer was dispatched to business parking lot in reference to a burglary of a motor vehicle call. Upon arrival the officer was directed to meet with the complainant who was reportedly waiting in the lounge. The male complainant said he was about to go home when he went outside and noticed his rear passenger window was broken out. He said he immediately called for police assistance. The male told the officer he did not see anything missing and none of the electronics were tampered with at all. The male reported that he arrived around 7:30pm and had not returned to the vehicle until he was ready to leave at approximately 10:10pm. The officer examined the area around the truck and noticed glass inside and outside the vehicle. There were no tools or objects left that could have been used to break the glass. The interior appeared intact and nothing was missing. There was a small brown napkin stained with what appeared to be

blood found on the ground just outside the broken window. The napkin was photographed in place and the item was recovered as evidence. This case is under investigation.

Offense: Open Door

An officer observed the inner double doors of a business to be open. The officer stopped at the exterior double doors to ensure that they were secure. As the officer pulled at the doors, they opened, allowing access to the facility. The officer contacted the dispatcher and notified them of the open doors. A HCV officer as well as two HPPD officers arrived to clear the building. The officer attempted to make contact with the key holder. A voice message was left without a return call. The officer was able to secure both sets of the main doors from the inside and exited out of a self-locking door at the rear of the facility.
