Offense: Driving While Intoxicated

Time: 0241 hours

Location: 800 Blk. Bitters Road

An Officer was concluding a traffic stop in the 800 block of Bitters Road when the sound of a passing vehicle hitting and running over the curb was heard. The Officer identified the vehicle and conducted a traffic stop at the intersection of Blanco Road and West Bitters Road. Upon contacting the driver, the Officer detected signs of intoxication. The driver was asked to complete Standardized Field Sobriety Tests. As a result of the driving over the curb, the signs of intoxication present, and the results of the SFST's, the driver was arrested for Driving While Intoxicated. The Driver was transported a nearby police stations where a breath sample was provided. The breath sample showed the Driver's Blood Alcohol Content was over two times the legal limit. The Driver was transported to the Magistrate's Office and booked for DWI.

An Officer was requested to respond to a local business located in the 13800 block of San Pedro Ave. Upon the Officer's arrival, contact was made with the Manager of the business. The Manager informed the Officer that an individual backed up their car to the front of the store, exited the car, cut a lock and proceeded to steal a lawnmower that was for sale. The Manager stated the incident was captured on the surveillance cameras outside of the store. This recording as submitted to the Officer as evidence. The Officer was able to obtain identifying information

on the suspect and the suspect vehicle from the recording. This case was forwarded to the Investigations Unit for follow up.

Offense: Driving While Intoxicated/ Unlawful Carrying of Weapon

In reference to this below DWI charge, investigation revealed that the driver was in possession of a firearm at the time of his arrest. As a result, an additional charge of Unlawful Carrying of Weapon will be filled with the District Attorney's Office.

A local business located in the 15700 block of San Pedro called the Police Department and requested an Officer respond for an individual who was passed out in the drive thru. Upon the Officer's arrival, the subject was still passed out and had not moved. The Officer requested a cover unit and began to wake the driver. After several minutes, the driver woke up. The driver showed signs of intoxication, so the Officer moved the vehicle out of the drive thru lane and conducted a field sobriety check. Based on the subject's behavior and performance on the field sobriety check, the Officer believed the subject was intoxicated over the legal limit. The driver was arrested for Driving While Intoxicated.
