Offense: Driving While Intoxicated

Date: 01.28.18

Time: 0029 hours

Location: 500 Blk. Tomahawk Trail

An Officer was driving in the 500 block of West Bitters Road and observed a vehicle swerving from one lane into another. The vehicle continued east on Bitters Road until the driver made a left hand turn onto Tomahawk Trail. The Officer observed that when the vehicle made this turn, two approaching cars had to slam on the breaks to keep from colliding with the vehicle. Due to the factors listed above, the Officer conducted a traffic stop on the vehicle. Based on the contact with the driver, the Officer determined the driver had been consuming alcoholic beverages. The Officer requested the driver complete Standardized Field Sobriety Tests to determine if the driver could safely operate the vehicle. Base on the totality of the circumstances from the Officer's contact with the driver, the Officer believed the driver was intoxicated over the legal limit. The driver was subsequently arrested for Driving While Intoxicated. During an Inventory of the arrested person's vehicle, open bottle of Vodka was found on the driver side, rear floorboard. The Driver was transported to the Magistrate's officer where breath specimens were collected. The breath specimens revealed the drivers Blood Alcohol Level was greater than double the legal limit of 0.08.

An Officer conducted a traffic stop on a vehicle that was observed speeding in the 500 block of West Bitters Road. The Officer identified the driver by their name and date of birth. The Officer conducted a computer check on the name and date of birth, which revealed several outstanding

warrants for the driver's arrest. The return also showed the driver's license was suspended. The Officer verified the warrants were active and placed the driver under arrest. The driver was transported to 401 South Frio and booked on the outstanding warrants.
