Calls of Interest

Offense: Driving While Intoxicated

Date: 02.04.18

Time: 0103 hours

Location: 200 Blk. W. Bitters Rd.

An Officer observed a vehicle speeding in the 200 block of West Bitters Road. The Officer conducted a traffic stop on the vehicle due to the speeding violation. Upon contact with the driver, the Officer detected an odor of an alcoholic beverage coming from inside the vehicle. The Officer asked the driver if they had been drinking and they stated they had. The Officer asked the driver if their intoxication level had led to their speeding and the driver stated it had. At this point, the Officer had the driver exit the vehicle to conduct field sobriety testing. The driver, however, stated that they would not submit to any testing or further evaluation. Due to the factors observed by the Officer, the driver was placed under arrest for Driving While Intoxicated. At the Magistrate's office, it was learned that the driver had two previous convictions for Driving While Intoxicated. As a result, this case will be filled as a Felony charge. The Officer obtained a blood warrant and collected a specimen for analysis of the driver's blood alcohol content.

Offense: Driving While Intoxicated

Date: 02.05.18

Time: 0011 hours

Location: 13400 Blk. San Pedro

While conducting business patrols, Officers heard a loud noise coming from the highway in the 13400 block of San Pedro. Officers could see the white top of a pickup truck passing by on the

highway as the noise went by. Officers drove down the frontage road of San Pedro in an attempt to locate the source of the noise. At the intersection of San Pedro and Bitters Road, a white pickup truck was in the middle lane. The vehicle behind the truck waived the Officers down and stated "that's the one". At this time, it was observed that the truck was missing tires on three of the vehicles wheels. The noise heard by Officers was the truck driving by on three rims. The vehicle was stopped in a nearby parking lot where contact was made with the driver. The witnesses pulled in and stated the truck had struck numerous highway signs and barricades along Loop 1604 and IH10. The driver exited the vehicle and appeared to be intoxicated. Officers requested he complete field sobriety tests, but the driver refused. Due to the signs of intoxication and the vehicle damages sustained by the driver's colliding with street signs and barricades, the driver was placed under arrest for Driving While Intoxicated. At the Magistrate's office, the subject refused to provide a breath sample, so a blood warrant was obtained. Once completed, a specimen of the driver's blood was drawn for analysis of their blood alcohol content.

Offense: Theft \$2,500 < \$30,000

Location: 15700 Blk. San Pedro

An individual called Police to report a theft that had just occurred. Upon an Officer's arrival, the called stated they had placed two rings inside a gym bag along with a pistol and wallet. While exercising, the caller's gym bag was stolen from their unlocked gym locker. The caller provided serial numbers and identifying information on the items taken. This case was forwarded to the Criminal Investigations Division for follow up.

Offense: Driving While License Invalid/Poss. Narcotic Paraphernalia

Location: 300 Blk. W. Bitters Rd.

An Officer observed a vehicle speeding in the 300 block of West Bitters Road. As a result, a traffic stop was conducted on the speeding vehicle. Upon contact with the driver, the Officer observed what appeared to be a marijuana smoking pipe in the driver side door handle. The driver also informed the Officer that their license was not valid at the current time. The Officer requested a cover unit to make the location. Upon arrival of the cover Officer, the driver was asked to exit the vehicle. The Officer conducted a search of the vehicle and located two marijuana pipes with marijuana residue in each pipe. The Officer also discovered a metal grinder with marijuana residue. Lastly, the Officer located numerous rolling papers and cigarillos. All items were removed and secured as evidence. Upon completion of a computer check on the driver, the license was verified as suspended. The driver's vehicle was impounded due to the status of the license. The driver was issued citations for the narcotic paraphernalia, driving while license invalid, and no insurance.

Location: 13800 Blk. San Pedro

A driver was stopped for speeding in the 13800 block of San Pedro. The driver identified themselves to the Officer, who conducted a computer check of the driver's license. The return revealed the driver has a suspended license. The return also showed the driver had previous convictions for driving while license invalid. As a result, the driver was arrested for driving while license invalid, enhanced. The driver's license return also revealed that the driver had several active warrants for their arrest. The driver was transported to the Magistrate's office and booked on the warrants and new charge of driving while license invalid, enhanced.
