Offense: Burglary of Building

Location: 15600 BLK. San Pedro

Officers were dispatched to a business in the 15600 block of San Pedro for an activated alarm. Upon arrival, Officers observed shattered glass to a rear entry door. Officers notified dispatch and checked the interior of the building and observed several items had ben rummaged through. The store manager made the location and reviewed the store surveillance video with the Officers. From the video, a suspect was observed smashing out the window, entering the store, and rummaging through the office drawers. The surveillance video was recorded and secured as evidence. This case will be forwarded to the Criminal Investigations Division.

An Officer conducting a business patrol observed a vehicle parked in front of a local business located in the 15300 block of San Pedro. When the Officer contacted the driver of the truck, it was learned that the driver was an employee of the business. The employee pointed out that two office windows had been shattered. The employee unlocked the office and the Officer checked the interior of the building. With the exception of the damaged windows, there did not appear that any criminal activity had occurred inside the business. The damage was photographed and they report forwarded to the Criminal Investigations Division.

An Officer was dispatched to a local business in reference to the burglary. Upon arrival, an Officer contacted the business owner who stated they had locked up the store the previous day, but upon their return, they observed change scattered on the floor. The owner looked into the cash register and observed all the change from the register had been taken. It appeared the unknown suspect had dropped some of the change as they exited the store. At the time of this report, the owner did not see any forced entry to the store and did not know how they could have entered. The following day, the business owner called back and reported they had found a whole on the back side of the store where it appeared the suspect had forced entry into the store. The scene was photographed and processed for evidence. This case was forwarded to the Criminal Investigations Division for follow up.
