## **Calls of Interest**

Offense: Driving While Intoxicated

Offense: Possession of a Controlled Substance

While on patrol in the 100 block of Cherokee Lane, an officer observed a gray vehicle parked and running along a darkened section of roadway. The vehicle did not have any lights or parking lights on and as the officer approached, he could hear the vehicle running through the open window of the patrol vehicle. As he was beginning to pass the vehicle, he noticed that the driver's side window of the gray vehicle was lowered and recognized a males subject sitting sloped in the driver's seat. Contact was made with the driver to ensure that all was in order. As the officer approached the lowered window, he immediately detected an odor of marijuana emitting from the vehicle. The driver was asked to present his identification, but the driver stated that he only had a student ID card. The officer inquired about the odor of marijuana at which time the driver stated that he had used earlier in the day and that it may have been residual odor. The officer advised the driver that due to the odor of marijuana, a check of the vehicle would be conducted. Immediately after opening the driver's side door the officer noticed two clear plastic baggies on the floorboard, just under the driver's seat. The officer could tell that one of the baggies had a green leafy substance that appeared to be marijuana. The officer also discovered a baggie containing a yellow rectangular pill, which was believed to be Xanax. As a result of these items, the driver was taken into custody. The drugs were identified and tested. The marijuana was weighed 1.3 grams. The driver was transported to the Magistrate's Office and booked. The case will be forwarded to HCVPD/CID for further investigations.

Offense: Burglary of Habitation

Location: 100 blk Tomahawk Trail

An officer was approached by a resident at 116 Aspen Lane in order to file a Theft report. The resident discovered two bicycles were taken from his garage. The resident noticed the bicycles were taken at approximately 0800 hours on 06/24/2017. Each bicycle was worth \$2,000.00. The homeowner explained to the officer that the last time he saw his bicycles was approximately 1200 hours on Sunday, 06/18/2017. The suspect identity is unknown at this time.
