Offense: Driving While Intoxicated

Date: 07.01.18

Time: 0104 hours

Location: 1000 Blk. West Bitters Road

An officer stopped a vehicle for a traffic violation in the 1000 block of West Bitters Road. Upon contact with the driver, the officer detected a strong odor of an alcoholic beverage emitting from the vehicle. The officer had the driver and sole occupant exit the vehicle. The driver completed the officer's field sobriety test, which indicated the driver was impaired by the induction of alcohol. Subsequently, the driver was arrested for Driving While Intoxicated. The driver was asked to provide a specimen of breath for an analysis of their blood alcohol level, but the driver refused. As a result, the officer applied for, and was granted, a warrant to have the driver's blood drawn. The driver was booked for Driving While Intoxicated. This case was forwarded to the Criminal Investigations Division.

An officer was contacted by a resident regarding property they had found in the 100 block of Cabin Path. The officer responded, located the resident and subsequently the property. The property was collected and returned to the police station where the officer attempted to locate any possible latent finger prints. The property and collected evidence was forwarded to CID for follow up investigation.
