Offense: Minor Consuming Alcohol

Time: 2345 hours

Location: 13600 Blk. Treasure Trail

Officers had cleared a call for service involving Criminal Mischief that had occurred in the 13600 block of Treasure Trail. While checking the area, officers' observed a vehicle parked in the middle of the street. Officers' went to the residence close to where the car was parked in order to make contact with the vehicle owner. While waiting at the door, several young individuals were seen walking out the back door of the residence. The front door was opened by a person residing at the residence. When asked if the parents were home, the officers' were told no. Through the back windows, several alcoholic beverages could be seen. When asked how old the people at the residence were, the officers' were told 18-19 years old. Upon further investigation, it appeared the person who opened the door, and lived at the location had thrown a party. At that party, it appeared the person had consumed alcoholic beverages. As a result, the person was issued a summons for Minor Consuming Alcohol. The remaining alcohol was photographed and discarded. A small amount of marijuana and one white pill were collected and secured in the property room. No further action was taken.

A local business called to file a police report for Burglary of Building. Upon the officer's arrival, the manager showed the officer a side glass door, which had been shattered. According to the manager, an unknown suspect(s) broken into the business through the glass door. Once

inside, the suspect(s) stole all the cash out of the register. The manager was not immediately aware of how much money was inside the register. The manager stated the business did not have security cameras or an alarm system at the time of the burglary. The officer attempted to collect latent prints, but did not locate any. This case was forwarded to CID for follow up investigation.

An officer was contacted to make a local business in the 15600 block of San Pedro. Upon arrival, the officer contacted a land lord and tenant of the business. Once inside, the unknown person(s) kicked in the door to the tenant's suit. While the tenant did not immediately notice any missing items, they did state the television had been turned on and cabinets had been rummaged through. The officer provided the land lord and tenant with a case number and property loss supplement forms in case items were notice missing at a later time. No further action was taken.

An officer conducting stationary radar in the 500 block of West Bitters, observed a vehicle traveling over the posted speed limit. The officer turned around and activated the emergency lights on the patrol vehicle to signal the driver to stop. As soon as the officer did this, the vehicle quickly accelerated. As the officer briefly followed, the vehicle swerved into oncoming traffic in an attempt to get away from the officer. The officer immediately slowed down and dis engaged in attempting to stop the violator. The officer broadcast the vehicle description over the radio for surrounding units to be on the lookout. A case for Evading – Motor Vehicle was completed and submitted to CID for follow up investigation.
