## **Calls of Interest**

Offense: Burglary of Business

Date: 08.27.17 Time: 0850 hours

Location: 15600 blk. San Pedro

An officer was dispatched to a local business for a burglary of a business report. On arrival, the officer contacted the manager. The manager was contacted by the property manager of the strip center, who said while checking the surrounding businesses for storm damage, two knife boxes were found in the parking lot, one empty and one containing a knife. The strip center manager then noticed the business had been broken into. Entry into the business was made through the office entry door, which is directly to the left of the main entry door. The door had been pried open with an unknown object breaking the lock and surrounding door frame allowing an unknown subject to make entry without the effective consent of the store manager. Once inside the unknown subject made their way to the Benchmade display case and pried open the storage door at the bottom of the display. Once inside the case the unknown subject took an unknown number of Benchmade knife boxes. The manager was unable to find anything else missing from the business at this time. Two latent prints were lifted from the display case and taken into evidence. The top of the frame from the bottom storage door had been broken off and was taken into evidence. The two Benchmade knife boxes that were found in the parking lot were also taken as into evidence. The evidence was transported back to the Hill Country Village PD and submitted into evidence. An officer received a call via city cell phone from an employee at a local business requesting police assistance to make a theft report. Upon arrival to the business, the employee stated they were a witness to a theft of two sound bars from their Sonos Speaker area. The employee advised that a suspect wearing a white t-shirt and blue jeans, came into the store and was looking around at different products. The unknown subject inquired over several items and proceeded to shop around. The employee advised the unknown subject entered the Sonos Speaker area and inquired for a price over some speakers. While the employee looked for the price information, the unknown subject grabbed two boxes containing Sonos Play 5 sound bars and proceeded to walk towards the main counter. Once the unknown subject reached the counter, they ran past the point of sale and exited the store without paying for the sound bars. The employee stated that the unknown subject got into a Gold Chevy Malibu bearing temporary tags. The employee was unable to get the temporary tag number. The surveillance footage showed the gold Chevy Malibu with dark tinted windows enter the parking lot towards the back and drove alongside the building stopping at the front entrance of the store. The unknown subject exits the front passenger side of the vehicle and walks into the store. The subject is seen walking around the store looking at different items for about 10 minutes before they decided to take the Sonos Play 5 sound bars. As the subject leaves the store and is running towards the vehicle, the front passenger door opens and the subject gets in and the vehicle leaves the premises. The temporary tag was unreadable in the surveillance footage. A copy of the footage was provided and tagged into evidence. This case will be forwarded to CID.

An officer was contacted by a resident via the city cell phone. The resident wanted to report a theft at their residence.
