Calls of Interest

Offense: Crash

Date: 11.28.17

Time: 1215 hours

Location: 15700 Blk. San Pedro

An Officer was dispatched to a Non-Injury Crash at a local business in the 15700 block of San Pedro Ave. Upon the Officer's arrival, contact was made with the reporting party, who stated their vehicle was parked in the parking lot and another vehicle backed into their vehicle. The reporting party exited the business and made contact with the second driver, who advised they were unaware that they had struck another vehicle. The Officer observed no damage to either vehicle, but was told the rear bumper of the first vehicle was unaligned after the crash. The Officer did observe a small gap in the rear bumper of this vehicle. The Officer stood by while both parties exchanged insurance information and took pictures of each other's vehicles. Both of them were given a HCV case number and departed location without further incident.

Offense: Violation State Vehicle Laws

Location: 500 Blk. W. Bitters Rd.

An Officer observed a vehicle driving in the 500 block of W. Bitters Road with an obscured license plate. The plate number was covered with dirt, paint, and the ball hitch was obscuring the view of the plate. The bumper was also bent downward, which made the plate unreadable. As a result, the Officer conducted a traffic stop. The Officer made contact with the Driver and informed them why they had been stopped. The Officer asked for the Driver's license, which they did not have. The Driver did provide a Texas ID card. A computer check showed the Driver had a Not Eligible status on their license. The Driver also showed to have multiple active

suspensions and previous convictions for driving with a suspended license. The Driver was issued citations and a separate charge for driving with a suspended license will be filled at large. The Driver called for a ride and departed the location.

An Officer was dispatched to a local business in the 15300 block of San Pedro for a Keep the Peace call. The Officer arrived and contacted the reporting party, who advised they had quit their position at the local business due to personal reasons. The reporting party also stated they needed to return their office keys and pick up personal items inside the business. The Officer contacted the management inside the office and advised them of the situation. The Officer returned the office key and stood by while the reporting party obtained their personal items. No further action was needed and the Officer returned to service.

Offense: Narcotic Possession

Date: 12.01.17

Time: 2112 hours

Location: 500 Blk. W. Bitters Rd.

An Officer was conducting stationary speed enforcement in the 500 block of West Bitters Road when a black Acura driving eastbound with no tail lights illuminated was observed. The Officer turned behind the vehicle and activated the emergency lights of the patrol unit. The driver of the vehicle turned onto a side street and stopped. As the Officer made contact with the driver and sole occupant of the vehicle, the Driver appeared nervous, talking quickly and their hands were noticeably shaking. The Driver stated their license had been suspended, but should have been reinstated as of 12-01-2017. The Driver stated they did not have their license or any other identification with them. The Officer obtained the Driver's name and date of birth so a computer search could be conducted. The Officer also asked for the insurance on the vehicle. The Driver stated the vehicle was a friends and they were not sure if the friend had insurance. The Driver was able to produce an insurance card that had expired in 2014. While the Driver was looking for the insurance, the Officer also observed the registration for the vehicle had expired in 2014. While speaking to the Driver, the Officer could detect an odor of Marijuana coming from the vehicle. The Officer returned to the patrol unit and conducted an MDT check on the Driver and vehicle. The Driver's license return showed a clear status. The vehicle, however, did not return with a valid insurance return. The Officer returned to the vehicle and asked the Driver if they could obtain some form of proof of insurance for the vehicle. The Driver was unable to produce insurance coverage on the vehicle. Due to the fact that the registration was expired as of 12-2014 and no valid insurance could be produced or verified from the insurance database, the Driver was told the vehicle would be impounded. The Officer returned to the patrol unit and began to complete the Inventory paperwork. A cover Officer was asked to obtain a phone number from the Driver. This Officer returned and stated they had also detected the odor of marijuana coming from the Driver. At this time, Officers instructed the Driver to walk to the front of the patrol unit. As Officers began a pat down of the Driver, the Driver stated "it's in my

pocket". Inside the Driver's right front jean pocket were two plastic bags of a green leafy substance that appeared to be Marijuana. The Driver was placed in handcuffs and detained in the back seat of my patrol unit. While conducting the vehicle inventory, a black smoking pipe with marijuana residue and two partially smoked marijuana blunts were located in the front area of the car. All items listed above were collected and secured. Officers conducted a field test on the green leafy substance which returned a presumptive positive test result for Marijuana. The Driver was arrested and booked at the Magistrate's Office.
