MINUTES SPECIAL CITY COUNCIL MEETING CITY HALL 116 ASPEN LANE HILL COUNTRY VILLAGE, TEXAS 78232 THURSDAY, MAY 23, 2019 5:00 P.M.

The City Council for the City of Hill Country Village met for a City Council Meeting Thursday, May 23rd, 2019 at 5:00 p.m. at City Hall, 116 Aspen Lane, Hill Country Village, Texas. This was an open meeting subject to the open meetings law of the State of Texas.

1. Call to order.

Mayor Durand-Hollis called the meeting to order at 5:04 p.m.

2. Moment of Silence and Pledge of Allegiance.

Mayor Durand-Hollis led those present in a moment of silence and the Pledge of Allegiance.

3. Discussion and possible action approving an ordinance declaring each unopposed candidate for the May 4, 2019 General Election elected to office.

Councilman Acock motioned to approve an ordinance declaring each unopposed candidate for the May 4, 2019 General Election elected to office, seconded by Councilwoman Greer. Motion passed unanimously.

Councilman Doyle, Councilwoman Greer and Councilman Register were sworn in by Mayor Durand-Hollis.

Mayor Durand-Hollis asked the council for a motion to appoint a Mayor Pro Tempore. Councilwoman Greer motioned for Councilman Doyle to be Mayor Pro Tempore, Councilman Neal seconded the motion. Motion passed unanimously.

CONSENT AGENDA:

The following items are of a routine or administrative nature. The City Council has been furnished with background and support material on each item, and/or it has been discussed in a previous meeting. All items can be acted upon by one vote without being discussed separately, unless requested by a Council Member or the Mayor, in which event the item or items will immediately be withdrawn for individual consideration in their normal sequence after the items not requiring separate discussion have been acted upon. The remaining items will be adopted by one motion and vote of the City Council.

5. Discussion and possible action approving the minutes of the City Council Meeting of March 21, 2019.

Councilman Acock motioned to approve the minutes of the City Council Meeting of March 21, 2019, seconded by Councilwoman Greer. Motion passed unanimously.

INDIVIDUAL ITEMS FOR CONSIDERATION:

6. Citizens to be heard.

At this time, citizens who have filled out a registration form prior to the start of the meeting may speak on any topic they wish to bring to the attention of the governing body so long as that topic

is not on the agenda for this meeting. Citizens may speak on specific agenda items when that item is called for discussion. During the Citizens to be Heard section no council action may take place and no council discussion or response is required to the speaker. However, the Mayor or the City Administrator may make a statement of specific factual information in response to an inquiry or recite existing policy in response to an inquiry. A time limit of two minutes per speaker is permitted; the council may extend this time at their discretion.

There were no citizens to be heard.

7. Discussion and possible action on a Development Agreement between the City of Hill Country Village and Embrey Partners, Ltd. or its assignee concerning the property legally described as an 11.999 acre or 522,689 square feet, more or less, tract of land being parcels 2,3,4,5, and 6 described in deed to Marmon Family Properties, Ltd. Recorded in Volume 6575, Page 1539, of the Official Records of Bexar County, Texas, and a 6.128 acre tract described in Deed to Marmon Family Properties, Ltd. Recorded in Volume 16352, Page 1197, of the Official Records of Bexar County, Texas, and a 0.856 acre portion of the HCV Tower, LLC property.

Mr. Jimmy McCloskey of Embry Partners answered council member's questions about the proposed development.

Councilman Acock motioned that we resolve that the City of Hill Country Village enter into a Development Agreement with Embry Partners, Ltd. or it's assignee in regard to the 11.999 acre parcel of land described in exhibit A to this resolution and a 0.856 acre parcel of land now owned by HCV Tower, LLC substantially and materially in the form of the Development Agreement presented to the City Council on May 23, 2019 inclusive of exhibits A, B, C and D resolved further that Gabriel Durand-Hollis, Mayor of the City of Hill Country Village, be and is hereby authorized to execute on behalf of the city, a Development Agreement in accordance with the foregoing resolution, seconded by Councilman Register. Motion passed unanimously.

8. Discussion and possible action approving a Resolution of the City of Hill Country Village, Texas, supporting Census Programs, Surveys, and Other Critical Preparations for Accurate Enumeration in the 2020 Census; and providing an effective date.

Mr. Dwayne Robinson, Constituent Services Director for Bexar County, addressed the city council about Census Programs, Surveys, and Other Critical Preparations for Accurate Enumeration in the 2020 Census.

Councilwoman Greer motioned to approve a Resolution of the City of Hill Country Village, Texas, supporting Census Programs, Surveys, and Other Critical Preparations for Accurate Enumeration in the 2020 Census; and providing an effective date, seconded by Councilman Register. Motion passed unanimously.

9. Discussion with personnel from Frost Bank Capital Markets regarding financing for a possible bond package.

Councilwoman Greer motioned to reappoint existing members Mr. Steve Marceau and Mr. Greg Blasko to the Business Construction Review Board, seconded by Councilman Acock. Motion passed unanimously.

19. Discussion and possible action appointing new members and/or reappointing existing members to the Economic Development Corporation Board.

Councilwoman Greer motioned to reappoint existing member Mr. Blasko and appoint Mr. John Dulske to the Economic Development Corporation Board, seconded by Councilman Leonard. Motion passed unanimously.

Mr. Doug Boom and Mr. Jeff Garvens have resigned their positions.

20. Report by Mayor on matters of community interest.

Mayor Durand-Hollis did not have anything to report.

21. Report by City Administrator/Chief of Police on matters of community interest.

City Administrator Morales reported City Hall would be closed Monday, May 27th, 2019 in observance of Memorial Day.

Administrator Morales also wanted to thank Councilman Register for serving as Mayor Pro-Tempore for several years. He praised Councilman Register for always being so helpful.
