Details: On the above date and time, a HCVPD Officer observed a vehicle to be traveling at a high rate of speed. As the vehicle passed the officer, the officer turned around and chased the vehicle. The vehicle turned down Aspen lane and tried to evade the Officer. The officer caught up to the vehicle at W. Bitters and Tower where he conducted a traffic stop. The officer identified the suspect and released him since he did not have all the information needed to arrest the suspect for evading. The Officer was later able to identify the suspect as the person evading him by using dash and body cams. The suspect was later filed on at large for Evading arrest / Vehicle by the Officer and the CID unit.

The officer took the person to the hospital and release the person to them as an Emergency Detention.
