Offense: Narcotic Laws

An officer stopped a vehicle for speeding in the 13800 block of San Pedro Ave. As the officer contacted the driver, an odor of marijuana was detected coming from inside the vehicle. The officer asked the driver about the odor at which time the driver admitted to having marijuana in the vehicle. The driver was removed from the vehicle and a search was conducted. The officer removed the marijuana and narcotic paraphernalia discovered in the search. These items were secured as evidence. The driver was release from the scene with narcotic possession and narcotic paraphernalia charges pending.

The search revealed a small amount of contraband. The driver admitted to smoking marijuana earlier in the day, so the officer advised the driver to contact someone to make the location of the stop and pick them and their vehicle up.
