Offense: Evading Arrest

Details: HCVPD Officer observed a vehicle pull into a business park at the above location. The vehicle's hazard lights were on and the HCVPD officer attempted to pull behind the vehicle. The driver of the vehicle put the vehicle in reverse and the officer had to move to avoid a traffic accident. The vehicle then left the location and began to speed on the north bound access road of San Pedro. The vehicle disregarded several red lights. The officer turned on his emergency lights to stop the vehicle and a chase ensued. After a long chase, the vehicle was stopped by placing spikes down and deflating the tires. Once the driver was taken into custody, she was placed under arrest for Evading Arrest / Vehicle and transported to BCSO Jail to be booked.
