Offense: Evading Arrest/ Detention

Details: A HCVPD Officer while conducting traffic enforcement in the 14400 Blk. of San Pedro noticed a vehicle to be traveling faster than the posted speed limit. Officer attempted to conduct a traffic stop at which time the driver of said vehicle refused to come to a stop. Officer continued to pursue said vehicle ending up with officer engaged in a vehicle pursuit. The pursuit finally came to an end once the driver of said vehicle wrecked out causing damage to officer's patrol vehicle. Driver of said vehicle was taken into custody and was also found to be in possession of narcotics. Due to the driver sustaining injuries, the driver was transported to the hospital for further evaluation. Criminal charges will be filed on the driver. The incident will be investigated by the CID unit.

Details: A HCVPD Officers was dispatched to 15665 San Pedro in reference to a burglary of building. Officers arrived on location and noticed the glass front door had been shattered. Officer entered the building to make sure no one was inside. Building was cleared and contact was made with the manager/ key holder who said he would be in route to the location. Manager/ Key Holder arrived at location and was able to provide officers with a list of items taken. It appears that an unknown person broke into the business and took different items without the consent of the owner. The suspect then left the area. There was video of the suspect. CID will follow up on the case.
