

Hill Country Village Calls for Service

Calls of Interest

Offense: Narcotic Paraphernalia

Date: 01/03/2023

Time: 9:00 pm

Location: 300 Blk. W. Bitters Rd.

Details: A HCVPD Officer was conducting traffic control in the 300 Blk. of W. Bitters and noticed a small motor vehicle traveling faster than the posted speed limit for the area. Officer was able to verify the vehicle's speed to be traveling sixteen miles over the posted speed limit, at which time the officer conducted a traffic stop on said vehicle. Officer made contact with the driver of the vehicle, and while making contact with the driver, the officer smelled a strong and pungent odor of marijuana emitting from inside the vehicle. Due to having probable cause the officer conducted a vehicle search at which time the officer located a marijuana cigarette that contained a green leafy substance (marijuana) in plain view next to the shifter. As the officer continued his search of the vehicle he also located a THC vaporizer. The driver was issued three Hill Country Village Court Summons and was released without incident. The officer confiscated the marijuana cigarette and vaporizer and they were inventoried and placed in the property locker. The incident will be forwarded to investigations for proper disposal of the marijuana.

Offense: Burglary of a Vehicle

Location: 104 Winding Way

Details: A HCVPD Officer was dispatched to 104 Winding Way for a Burglary of a Vehicle. An unknown person made entry into an Austin Bridge vehicle without the effective consent of the owner. Officers asked if there were any items missing from the vehicle. Officer was advised no items were missing; they just caused damage to the steering column. Officer took photos of the damage caused to the vehicle for their report. The incident will be forwarded to the CID unit for further investigation.

Offense: Unauthorized use of Motor Vehicle/ Evading in Motor Vehicle

Details: A HCVPD Officer received a call via the city cell phone for a suspicious vehicle. Officer arrived at the location, when the officer attempted to make contact with the subject inside the vehicle they sped off. A small chase ensued and the driver was apprehended shortly after with the assistance of Hill Country Village and Hollywood Park officers. The driver was quickly taken into custody for possession of stolen vehicle, Possession of a controlled substance which was located at the time of arrest, and evading in a motor vehicle. Female subject was transported to 200 N. Comal. The incident will be investigated by the CID unit.
