Offense: Wanted Person

Details: A HCVPD Officer was called back to the office for release of property. Once at location, the Officer made contact with the subject picking up property. The Officer asked for the subject's identification to assure he was releasing property to the correct individual and conducted a check of the subject's driver license information, at which time the return information showed the subject to have three active warrants from an outside agency. The Officer contacted BCSO and the dispatcher confirmed the warrants to still be active. Subject was taken into custody for the active warrants and was transported to 200 N. Comal to the Bexar County Jail. The incident was cleared by adult arrest.

Offense: Driving While Intoxicated (DWI)

Details: While conducting traffic control in the above location, a HCVPD Officer noticed a motor vehicle traveling at a slow rate of speed. The Officer was concerned the driver may be lost or having a medical emergency at which time the officer followed said vehicle and conducted a traffic stop. Once stopped the Officer made contact with the driver and while talking with the driver, the officer could smell the odor of an alcoholic beverage emitting from the person's breath. The Officer asked the driver if they would be ok if he checked to make sure they were ok to be driving. The driver agreed and the Officer had the driver exit the vehicle. The Officer performed Standardized Field Sobriety Test (SFST's). Upon completion with the (SFST's), the driver showed numerous signs of intoxication and unable to safely operate a motor vehicle. The Officer placed the driver under arrest and taken into custody for DWI. The driver was transported to 200 N. Comal to the Bexar County Jail. The incident will be forwarded to the CID unit for further investigation.

Details: A HCVPD Officer was dispatched to 14123 for a Burglary of a Vehicle. An unknown person made entry into several vehicles without the effective consent of the owner. Officers made contact with the owners of the vehicles to see if there were any items missing from their vehicles. The Officer was advised by vehicle owners that no items were missing from their vehicle. Vehicle owners stated they only had the damage that was done to their vehicles (broken Windows). The Officer took several photos of all the damage caused to all the vehicles for their report. The incident will be forwarded to CID unit for further investigation
