Offense: Graffiti

Details: As one of our HCVPD Officer was conducting checks at our local businesses they noticed a business within our city to have fresh graffiti on one of the side walls. The officer checked the building's exterior to assure there was no other graffiti on the walls. The officer took pictures of the graffiti on the build to attach to their report. The incident will be forwarded to CID unit for further investigation.

Offense: Narcotics Possession

Details: A HCVPD Officer was conducting stationary traffic enforcement in the 13800 blk. of San Pedro when he noticed a vehicle traveling faster than the posted speed limit for the area. The officer verified the vehicle's speed by utilizing the Light Detection and Ranging (LIDAR) to verify the vehicle's speed. The vehicle speed was verified at 67 MPH in a 45 MPH zone. Officer conducted a traffic stop on said vehicle which came to a complete stop in the parking lot of Taco Cabana. While the officer was making contact with the driver the officer smelled what he believed to be the odor of marijuana emitting from inside the vehicle. Officer conducted a probable cause search of the vehicle at which the officer located a substantial amount of narcotics located in the driver rear seat inside a black in color zip lock bag. The driver was taken into custody and transported to 200 N. Comal where he was booked into the Bexar County Jail without incident. The vehicle was towed by Texas Towing for safe keeping. The incident will be forwarded to CID unit for further investigation.

Details: A HCVPD Officer received a call for service in reference to a Forgery at SPS Designs. Officer arrived at the location and made contact with the accountant for the business. They stated they had received a call from their financial institution letting them know about the incident. They provided the officer with copies they had received from the bank showing the altered check. The officer generated a case in reference to the forgery, The incident will be forwarded to CID unit for further investigation.
