Details: A HCV Officer received a call for service in regards to a Burglary of a Vehicle that occurred at the above listed location. Once on scene the officer made contact with the owner of the vehicle who stated that his vehicle had been broken into. The owner advised the officer that his rear passenger window had been broken. The officer asked the owner of the vehicle what had been taken out of the vehicle. The owner stated a black backpack valued at \$140.00 dollars, a pair of headphone valued at \$140.00, and \$40.00 dollars in U.S. Currency had been taken out of the vehicle without his permission. The owner of the vehicle advised the officer, that he didn't believe any other items were missing. This incident will be forwarded to the CID for further investigation.

Details: A HCV Officer received a call for service in regards to a Burglary of a Building that occurred at the above listed location. Once on scene the officer noticed the front door to the business had been pried open to gain entrance inside the building without the effective consent of the owner. The officer made contact with the owner of the business, and asked if they could make location in reference to the Burglary. Once on location the owner was able to determine what inventory was missing from his business. The owner informed the officer there were five high valued bikes missing from his inventory and the total value of all five bicycle were over \$27,000 dollar. This incident will be forwarded to the CID for further investigation.

Details: A HCV Officer received a call for service in regards to an attempted Burglary of a Building that occurred at the above listed location. Once on scene the officer noticed the rear back overhead roll down door had a huge portion cut open to try to gain entrance inside the building. Due to the door having a reinforced inner door, no entry was made into the building. While on scene the officer was able to recover a stolen vehicle left behind by the actors. The officers were also able to recover the tools being used by the actor to attempt entry into the building. Officers were able to lift some latent finger prints from both the vehicles and tools. This incident will be forwarded to the CID for further investigation.
