Offense: Recovered Stolen Vehicle

Details: An HCV Officer received a call for service in the 15700 block of San Pedro for a Suspicious Vehicle. The Officer arrived at location and noticed the vehicle in question. The Officer noticed the vehicle to have all windows open, and have personal property inside the vehicle as well. The Officer conducted a check of the vehicle's license plate through TCIC/ NCIC. The return information on the vehicle came back to be a stolen vehicle out of the City of San Antonio. The vehicle was recovered by Texas Towing without incident for safekeeping until the owner of the vehicle could be notified. This incident will not be forwarded to the CID for further investigation.

Offense: Burglary of a Vehicle

Details: An HCV Officer received a call for service in regards to a Burglary of a Vehicle that occurred at the above listed location. Once on scene the officer made contact with the owner of the vehicle who stated that his vehicle had been broken into. The owner of the vehicle said that he believes he had been followed to this location. The officer asked the owner of the vehicle what had been taken out of the vehicle. The owner stated a black backpack valued at \$100.00 dollars had been taken out of the vehicle without his permission. The owner of the vehicle advised the officer that another person had photos of the vehicle and subject that burglarized his vehicle. Offense: Driving While Intoxicated (DWI)

Details: An HCV Officer was conducting a traffic stop in the 500 block of W. Bitters when a White in color truck passed by at a high rate of speed. Officer completed his traffic stop and was able to catch up to the truck and conducted a traffic stop. When the officer spoke with the driver, he could smell a moderate odor of metabolized alcohol emanating from the inside of the vehicle. The officer asked the driver to step out of the vehicle at which time the officer administered the Standardized Field Sobriety Test (SFST) to ensure that the driver was fit to drive. Upon completion of the (SFST) the driver was found to be unfit to drive a motor vehicle and was taken into custody for Driving While Intoxicated. This incident will be forwarded to the CID for further investigation.
