policy in response to an inquiry. A time limit of two minutes per speaker is permitted; the council may extend this time at their discretion.

7. Report by Mayor on matters of community interest.



9. Adjourn.


Mayor Durand-Hollis adjourned the meeting at 5:57 p.m.
