Offense: Warrant Arrest

Date: 08/06/2025

Time: 9:55am

Location: 15000 Block of San Pedro Avenue

Details: While conducting a traffic stop, HCV officer discovered that the passenger of the vehicle had a warrant for Driving While Intoxicated 3rd offense. HCV officer took custody of the passenger and transported the passenger to Bexar County Jail.

Incident: Animal Call

Location: 16418 Hidden View

Details: While patrolling a HCV officer received a call from a resident on the city patrol phone pertaining to loose dogs on the roadway. The caller stated he believed the dogs belonged to the resident at 16418 Hidden View. HCV officer made contact with the resident who confirmed the dogs belonged to her. The HCV officer was able to safely return the dogs to the resident.

Incident: Business Alarm

Location: 15703 San Pedro Ave (Discount Tire)

Details: A HCV officer was dispatched for a business alarm at Discount Tire. Upon the officers arrival he observed a male individual walking in the parking lot located behind Discount Tire. The HCV officer made contact with the individual. The individual stated he was knocking on the door at Discount Tire trying to get an employee's attention because his vehicle was left inside the business. While speaking with the individual the HCV officer became suspicious of the individuals reasoning for being at the business after business hours. The individual was detained while the HCV officer conducted an investigation. Upon further investigation the HCV officer discovered multiple overhead doors that someone had tried to open using construction tools. The individual stated he did not open the doors. The HCV officer checked for security cameras, there were none at Discount Tire or nearby properties. The HCV officer did not observe the individual in the act of opening the doors. The individual was identified and the incident is still under investigation by HCV CID.

Incident: Assist Outside Agency / Emergency Detention

Location: 15083 San Pedro Ave (Iron Ridge Apartments)

Details: HCV officers were dispatched for a suicidal individual at the Iron Ridge Apartments. When HCV officers arrived they made contact with the individual. The individual was suffering from a mental health crisis and stated "she wanted to end it all" while as she was crying. HCV officers spoke to the individual and deescalated the situation until Bexar County Sheriff's Deputies arrived and were able to emergency detain the individual. The individual was taken to the hospital for further evaluation.

Offense: Theft of a motor vehicle

Location: 237 Crest Trail

Details: A HCV officer was dispatched for a theft of a motor vehicle. The resident stated that two of his vehicles were taken from his residence without his permission. The HCV officer had observed one of the vehicles being towed from the area by a white tow truck with "We buy junk cars" decal on the vehicle. HCV CID was able to track down one of the vehicles on the south side of San Antonio. After further investigation it was discovered that an unknown individual had illegally obtained both vehicle titles and sold the vehicles without the owner's consent. HCV CID is still investigating the case.

Offense: Possession of a controlled substance / unlawful carrying a weapon

Location: 15000 San Pedro Ave

Details: While conducting a traffic stop for disregarding a stop sign. The HCV officer noticed a strong odor of marijuana coming from the vehicle. The HCV officer also observed a un holstered handgun on the driver side floor board. During a probable cause search, HCV officer found an electronic smoking device with a clear yellow liquid consistent with THC within the driver's immediate reach. The driver was taken into custody for possession of a controlled substance and unlawful carrying weapon and was taken to Bexar County Jail.
