A time limit of two minutes per speaker is permitted; the Board may extend this time at their discretion.

- 4. A public hearing, discussion and possible action regarding a request from Ms. Meg Paulus, H.F.O. Management, LLC company for variances to the Zoning Code, Chapter 78, Section 78-16 (C)(3) (A) which requires a front setback of 35 feet and Buildings and Building Regulations Code, Chapter 14 Section 14-104 which states the front fence may be no higher than 3 feet, as authorized by Howdy 222, LLC for the property located at 14723 San Pedro Avenue, City of Hill Country Village, Texas 78232 in the B-2 Zoning District and legally described as CB 5833 BLK 2 LOT E IRR 99.05 FT of 48 in Bexar County.

A public hearing, discussion and possible action regarding a request from Mr. Jeff Holt, for a variance to the Zoning Code, Chapter 78, Section 78-16 (B)(5)(B) which require a side setback of 50 feet, as authorized by the property owner for the property located at 207 Tower Drive, City of Hill Country Village, Texas 78232 in the R-2 Zoning District and legally described as CB 5833A BLK 4 LOT 100 in Bexar County.
